CONDITIONS OF APPROVAL This permit is granted upon the express condition that the persons or firm above named (as the contractor) agrees to comply with all ordinances, laws and orders in effect at this time in the City of Fort Atkinson, and the State of Wisconsin regulating the construction and zoning of buildings. This permit may be revoked at any time upon violation of any provision of said laws, ordinances or orders. This permit shall have lapsed and be void unless building operations are commenced within 60 days, and also unless the proposed construction is completed within two years from issuance.

- **Allow 24 hours to schedule inspections **Call before concealing any work.
- **Call DIGGERS HOTLINE before any excavation begins - 1-800-242-8511
- **All final grading shall conform to the original subdivision design and shall not cause erosion problems.
- **All attached garages floors shall be no higher than 2 feet above back of curb. Measurement to be taken from the center of the driveway approach to the garage floor.

Note: plumbing, electrical, and heating requires separate permits (note: heating may be included in new home projects.)
